Heat pumps installed by 5/31/20 will receive \$300 per outdoor unit. Heat pumps installed 6/1/20 - 12/31/20 will receive a \$600 credit per outdoor unit.

If your home or business is weatherized, you may qualify for an additional \$150. See below for details.

\*\*Important note: Starting on 1/1/2021, VEC is partnering with Efficiency Vermont to offer a single point-of-purchase incentive for heat pumps installed by contractors participating in the Efficiency Vermont network. Other than a possible \$150 thermal efficiency adder, no additional incentive is available through VEC for these units.

To qualify for an additional \$150 weatherization incentive, please provide documentation that your home or business meets one of the following criteria:

- Completed Home Performance with Energy Star project with Efficiency Vermont
- Received weatherization through the Weatherization Assistance Program (WAP) since 2005 or are currently enrolled in WAP
- Received a 2011 or newer Residential Energy Standards (2011 RBES) certificate
- Had a blower door test performed with a maximum measured Air Changes per Hour (ACH) of less than 5 at 50 Pascals
