Welcome to Vermont Electric Cooperative (VEC). Because you have recently purchased or rented property in our service territory, you are a new member of the Co-op.

This may be your first experience with an electric cooperative. The difference between VEC and an investor-owned utility is that, as a cooperative, VEC is owned by our customers—our member-owners. Any profit at the end of the year is allocated to members based on how much electricity they used. This is called member capital and a portion of this money may be returned to members each year, depending on the financial health of the Co-op.

Cooperatives are democratic in nature. Each member has an equal vote on matters such as bylaws, investing in long term power supply arrangements, and electing representatives to the Board of Directors, which governs VEC.

New customers automatically become member-owners of VEC.

Lastly, we are committed to providing you with the best possible service. We strongly encourage feedback from our members and look forward to serving you.

### SmartHub

With SmartHub, members can pay bills, view power usage, report outages, and set up alerts for power restoration and bill notifications. SmartHub is available on the web and for mobile devices.



### The Community Fund

The VEC Community Fund supports local organizations that promote community development and economic security. Participation is easy—simply let us know that you would like to round up your bill or donate your member capital.



### Beat the Peak

Beat the Peak encourages members to reduce their usage during peak times when energy demand is at its highest. This way, members can help control rising costs that impact electric rates.



### Co-op Community Solar

Members can sign up to sponsor solar panels for either 10 or 20 years and receive a credit on their monthly electric bills.



### Energy Transformation Program

VEC offers bill credits to members who purchase a range of products, including electric vehicles, heat pump water heaters, pellet stoves, induction cookstoves, electric lawnmowers and more. VEC may also offer a discounted line extension to off-grid homes or businesses.
