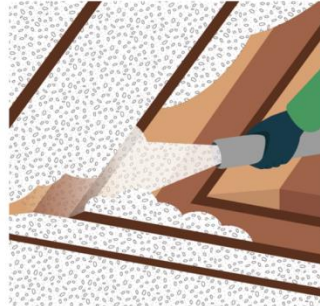
Weatherization

To qualify for the additional \$150 weatherization incentive, please provide documentation that your home or business meets one of the following criteria:

- Completed Home Performance with Energy Star project with Efficiency Vermont
- Received weatherization through the Weatherization Assistance Program (WAP) since 2005 or are currently enrolled in WAP
- Received a 2011 or newer Residential Energy Standards (2011 RBES) certificate
- Had a blower door test performed with a maximum measured Air Changes per Hour (ACH) of less than 5 at 50 Pascals

Why weatherize?

- Reduce heating costs
- Improve comfort and indoor air quality
- Increase the value of your home
- Projects can qualify for up to \$4,000 in rebates from Efficiency Vermont
